INFLATION

The revised Consumer Price Index records January 2012 inflation rate at 6.4 percent

The January 2012 Monthly bulletin reports the first Consumer Price Index (CPI) based on the new methodology and new software for data processing.

The annual rate of inflation, derived from the revised all items Consumer Price Index (CPI), was recorded at 6.4 percent, in January 2012.

Annual inflation rates for twelve (12) CPI Main Groups

The revised Consumer Price Index (CPI) is categorised into 12 main groups. The annual rate of inflation for Food and non-alcoholic beverages was recorded at 6.1 percent; Alcoholic beverages and tobacco (4.3 percent); Clothing and footwear (7.3 Percent); Housing, water and electricity (8.4 Percent); Furnishing

and household equipment (2.3 Percent); Health (6.7 Percent); Transport (12.3 Percent); Communication (0.0 percent); Recreation and culture (7.2); Education (10.7 Percent); Restaurant and hotels (4.7 percent); and Miscellaneous goods and services (3.3 percent).

National Average Prices of Selected Products

A comparison of retail prices between December 2011 and January 2012, shows that the average price of a 25 kg bag of white breakfast mealie meal reduced by 8.0 percent, from K47, 545 to K43, 747, while the national average price of a 20 litre tin of maize grain reduced by 1.1 percent, from K19, 429 to K19, 216. The national average price of 1kg of dried

kapenta (Siavonga) reduced by 15.1 percent, from K74, 979 to K63, 503.

However, the national average price of 1kg of tomatoes increased by 9.7 percent, from K3,700 to K4, 058, while the national average price of 1kg of cabbage increased by 12.1 percent, from K1,811 to K2,031.

BACKGROUND ON THE REVISED CONSUMER PRICE INDEX IN ZAMBIA

The Central Statistical Office (CSO) has Revised the Consumer Price Index (CPI) based on a new methodology including the revised basket of products, new weights, new index reference period and new software for processing the CPI.

The International Labour Organization (ILO) technical assistance Mission in May 2006 and the International Monetary Fund (IMF) technical assistance Mission conducted in 2009 assisted in the development of the new methodology for computing the CPI.

A second ILO technical assistance Mission was requested from ILO in September 2011. The Mission was funded by the African Development Bank (AfDB), and the main objective of this Mission was to review and validate the new Consumer Price Index (CPI) methodology, including data entry and processing software, before it is formally launched. An independent assessment from the ILO was required because its Mission had conducted a technical assistance Mission in May 2006 and had made some recommendations on the most appropriate methods for rebasing the index and selecting a new index among other things. In addition, the Mission was to provide additional guidelines on the treatment of the new elements in CPI design, on the basis of international standards and best national practices.

Following a recommendation by the Ministry of Finance and National Planning, a technical committee on the new CPI was formed. Membership of the technical committee was drawn from the following; Bank of Zambia, COMESA, Economics Association of Zambia (EAZ), Zambia Institute for Policy Analysis and Research (ZIPAR) the University of Zambia, the Jesuit Centre for Theological Reflection (JCTR), Ministry of Finance and National Planning, Central Statistical office. Further, the following three subcommittees were formed:

- (i) Methodology sub-committee to review and validate the new CPI methodology,
- (ii) Policy sub-committee to deal with policy implications of the new CPI results (i.e. the new CPI produces lower inflation rates)
- (iii) Sensitization sub-committee, with the responsibility of sensitization of stakeholders on the new CPI.

New CPI Methodology

Key features of the revised CPI include the following:

- A revised basket of goods and services from 357 to 440
- A new system of classification in accordance with international guidelines, namely Classification of Individual Consumption by Purpose (COICOP) (from 8 to 12 divisions)
- New expenditure weights from the 2002/2003 Living Conditions Monitoring Survey (LCMS)
- A new index reference period, from 1994 to 2009
- Use of Geometric Mean as opposed to Arithmetic Mean for calculating elementary level indices
- The New CPI in addition to National CPI, produces Provincial Indices

- Additional number of districts and outlets
- New computer system for data entry and data processing

Features of the New CPI Software

The New CPI System has been developed in Access with the following features: -

- ⤴ Uses Windows platform
- ⤴ Propagates centrally collected prices to provincial outlets
- ⤴ Validation is immediate, which allows immediate correction
- ⤴ Editing/ reviewing of quotations is flexible – permitting filtering of records of interest such as the threshold (upper and lower limits) values of price change rates
- ⤴ Prints Questionnaires from the application
- ⤴ System works in a Client-Server environment, supporting a minimum of 15 users concurrently
- ⤴ System is secure (implements log-on and roles)

INTERNATIONAL MERCHANDISE TRADE

December 2011 records Trade Surplus

Zambia recorded a trade surplus valued at K132.5 Billion in December 2011, representing a nominal decrease of 31.7 percent from K194.0 Billion recorded in November 2011. This means that the country exported more in December 2011 than it imported, in the same month, in

nominal terms, despite the decrease in the trade surplus.

Since January 2011, the country has had monthly trade surpluses with the highest valued at K1,484.3 Billion recorded in January 2011 and the lowest was in December 2011, valued at K132.5 Billion.

Exports by Major Product Categories, December and November 2011

Zambia's major export products in December 2011 were from the Intermediate goods category (*mainly comprising copper cathodes and sections of refined copper*) accounting for about 77.8 percent. Other exports were from the Consumer goods, Raw materials and Capital goods categories; which collectively accounted for about

22.2 percent of total exports in December 2011. This implies that between December and November 2011, the country has been a net exporter of Intermediate goods, mainly Metals and their articles, accounting for an average of 76.4 percent of the total exports for the two months.

Zambia's Metal Exports and Non-Traditional Exports (NTEs) December* and November 2011

There has been a decrease in the total value of exports from K3,882.3 Billion in November 2011 to K3,196.1 Billion in December 2011. The overall contribution of Metals and their products to the total export earnings in December and

November 2011 averaged about 72.3 percent. The share of NTEs recorded an average of about 27.7 percent in revenue earnings between December and November 2011.

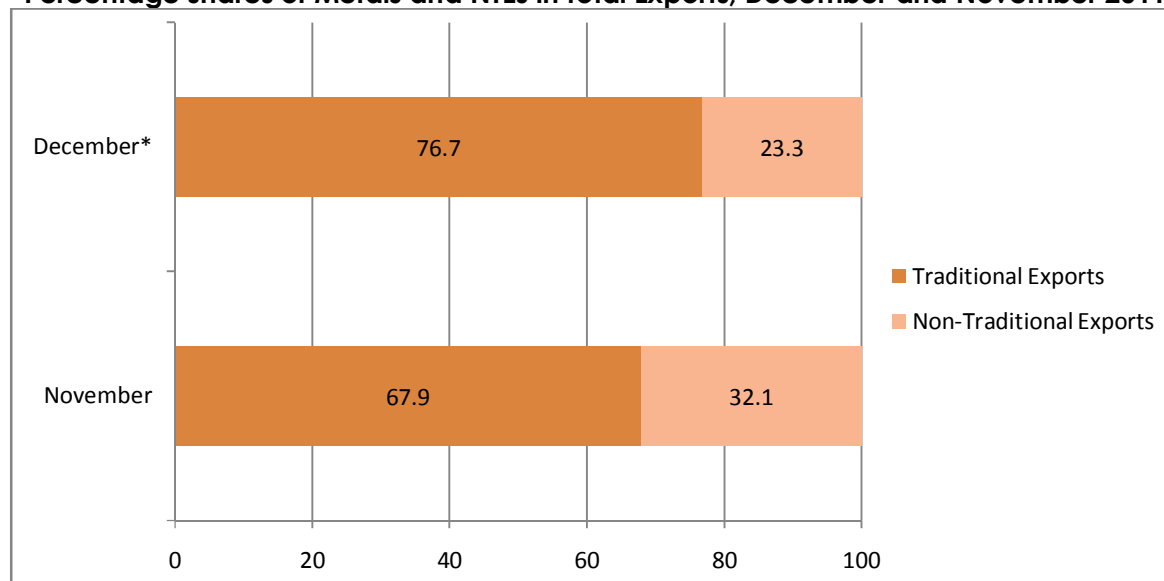

Zambia's Major Export Destinations by Commodity in December 2011

Zambia's major export destination in December 2011 was Switzerland, which accounted for 45.3 percent. The major export products to Switzerland were Cathodes & Sections of Cathodes of refined copper, accounting for about 86.2 percent.

China was the second major destination of Zambia's exports, accounting for 21.5 percent. The main export product to China was Copper blister (82.5 percent).

South Africa was the third major destination of Zambia's exports accounting for 8.3 percent. The major export product to South Africa was Maize (excluding seed) which accounted for 33.1 percent.

The United Kingdom was the fourth major export destination accounting for 5.9 percent. The main export products to the United Kingdom were Cathodes & Sections of Cathodes of refined Copper which contributed 64.8 percent to the country's share of exports.

Zimbabwe was the fifth major export destination, accounting for 4.5 percent. The main export product to Zimbabwe was Maize (excluding seed), which accounted for 67.3 percent.

These five countries collectively accounted for 85.4 percent of Zambia's total export earnings in December 2011.

Export Market Shares by Regional Groupings, December and November 2011

Asia was the largest market for Zambia's total exports, in December 2011, accounting for 22.9 percent. Within Asia, China was the dominant market in both December and November 2011 with 93.9

and 97.0 percent, respectively. The United Arab Emirates was the second dominant market in both months with 4.8 percent and 1.4 percent in December and November, respectively. Other

prominent markets were Singapore, India, Hong Kong and Korea.

The Southern African Development Community (SADC) regional grouping was the second largest market for Zambia's total exports, accounting for 21.2 percent in December 2011. Within SADC, South Africa was the dominant market in December with 39.0 percent while Zimbabwe was second with 21.3 percent. Other notable markets were Congo DR, Malawi and Swaziland.

The Common Market for Eastern and Southern Africa (COMESA) grouping of countries was the third largest market for Zambia's total exports, accounting for 12.7 percent in December 2011. Within COMESA, Zimbabwe was the dominant market with 35.6 percent and 42.9

percent in December and November 2011, respectively. Congo DR was second with 30.9 percent and 22.9 percent in December and November 2011. Other notable markets were Rwanda and Kenya.

The European Union (EU) was the fourth largest market for Zambia's total exports accounting for 8.8 percent in December 2011. Within the EU, the United Kingdom was the dominant market with 67.1 and 59.0 percent in December and November 2011, respectively. Luxembourg was second in December 2011 with 22.6 percent while Belgium was second in November 2011 with 20.0 percent. Other notable markets were The Netherlands, Poland and Germany.

The major source of Zambia's imports in December 2011 was South Africa, accounting for 43.9 percent. The major import products from South Africa were Dumpers for off high way use, contributing 3.8 percent to the share of imports.

The second main source of Zambia's imports in December 2011 was China,

accounting for 12.9 percent of the total value of imports. The major import products from China were Dumpers for off high way use accounting for 14.7 percent.

Other sources of Zambia's imports were Congo DR, Kuwait and India, collectively accounting for 14.4 percent of Zambia's total imports in December 2011.

Import Market Shares by Regional Groupings, December and November 2011

The Southern African Development Community (SADC) regional grouping was the largest source of Zambia's imports accounting for 54.3 percent in December 2011. Within SADC, South Africa was the main source of Zambia's imports in both December and November 2011 with 80.8 and 66.4 percent, respectively. Congo DR was second with 12.3 percent and 27.4 percent in December and November 2011, respectively. Other notable markets were Zimbabwe, Tanzania and Swaziland.

Asia was the second largest source of Zambia's imports accounting for 29.2 percent in December 2011. Within Asia, China was the major source of Zambia's imports accounting for 44.1 percent and 36.8 percent in December and November 2011. Kuwait was second with

15.4 and 16.7 percent in both months. Other notable markets were Japan, India and the United Arab Emirates.

The European Union (EU) was the third largest source of Zambia's imports in December 2011. Within EU, the United Kingdom was the main source, accounting for 28.1 percent, followed by Belgium with 13.8 percent. Other notable sources were Finland, Ireland and Sweden.

The Common Market for Eastern and Southern Africa (COMESA) grouping of countries was the fourth largest source of Zambia's imports in December 2011. Within COMESA, Congo DR was the main source of Zambia's imports in December 2011 with 63.5 percent, followed by Zimbabwe with 12.9 percent. Other sources were Kenya, Malawi and Egypt.
